

BULL DOMINGO RANCH PROPERTY OWNERS ASSOCIATION 2012 HUNTING REGISTRATION FORM

BDR Covenant XVIII allows property owners to hunt their own land. Hunting on Bull Domingo Ranch is limited to member's property only. There is no longer any BLM property on the ranch; however members do have access through the common area at the end of Dead Mule Lane on the north side of the ranch. All owners planning to hunt, or have invited guests hunting their property, must register with the Property Owners Association prior to the seasons being hunted by completing this registration form. This form includes the names of all persons authorized to hunt, the map and parcel numbers being hunted, along with the season dates and game being hunted. The registration should be signed by the property owner, along with a contact phone number and mailed to the Security Committee two weeks prior to season opening. Property owners are responsible for any guest and for ensuring those guests know the boundaries of the parcels being hunted and instructing their guests to adhere to all hunting regulations and regulations imposed by Bull Domingo Ranch. If property owners are unable to be present when guests are on their property, the guest must be registered and/or have written permission on their person, which contains the property owners name, map & parcel numbers, along with a phone number to contact the property owner. The use of BDR roads to access BLM lands is not allowed unless you are a property owner. No road hunting or shooting from a vehicle is allowed. Please see the BDRPOA Covenants, Bylaws and policies for complete rules regarding hunting. Please respect the volunteer patrol members, they are here to protect both hunting and non-hunting owners, as well as their properties. Do not trespass, you must get permission from the property owner or contact the Colorado Division of Wildlife before entering private property for any reason. You may contact one of the Security Committees or a Board Member for assistance
